#### **GUIDELINES FOR CONFERENCE PAPERS**

We would like to kindly invite authors to send the title and abstract of the paper by **February 20, 2024.** The title and abstract of the paper should be written in one of the official languages in BiH and in English (title 14 pt bold).

The summary should contain short answers to the questions: what were the motives / goals of the research, what was done, how it was done, what are the main results and what is the significance of the results.

Summarize the answers to a maximum of 150 words. Write the abstract in the form of one-column text, Times New Roman font, size 12, line spacing, margin 2.5.

It is necessary to write the title of the paper, name and surname of the author, name of the organization, postal address, telephone number, fax number and e-mail address. List up to five keywords at the end of the abstract. The abstract should be sent in electronic form to the Organizing Committee at the e-mail address: <u>konferencijaiut@gmail.com</u>

Along with the notice of acceptance of the abstract, the authors will receive instructions for writing the paper. Papers should be sent by **April 23, 2024.** The submitted papers will be reviewed, and the Organizing Committee will inform the authors about the acceptance of the paper by **May 3, 2024.**

Authors will be provided with a template for making a presentation along with a notification about the acceptance of abstracts. We ask the authors to prepare the presentation for presentation at the 28th International Conference in accordance with the template.

Papers and abstracts submitted after the deadline will not be considered or accepted!
